



22nd Photography Contest of Corrosion and Material Degradation Rules

1 – PURPOSE

The 22^{nd} Photography Contest of Corrosion and Material Degradation, organized by the Brazilian Association of Corrosion — ABRACO — and to be held at InterCorr 2025, aims to stimulate the dissemination of the characteristics and visual aspects (morphology) of the various types of corrosion for educational purposes.

2 – PARTICIPANTS

2.1. All registered participants at InterCorr 2025 may participate in the contest.

2.2. Each participant may apply to the contest with only ONE photograph.

3 – THEMES

All aspects of corrosion on parts and equipment.

4 – PRESENTATION

4.1. Black and white and color photographs will be accepted.

4.2. The photographs must be sent as JPG files, with a resolution of 300 dpi and a size up to 5Mb. Photographs outside this format will not be accepted.

4.3. Photographs with Photoshop treatment and/or highlighting details will not be accepted.

4.4. No photograph may contain trademarks or information identifying the author (s) and/or company (s).

4.5. Only technical descriptions will be accepted, not exceeding 300 characters.

5 – REGISTRATION DEADLINE

All photographs must be submitted by June 05th, 2025.

6 – EVALUATION PROCEDURE

6.1 Photographs submitted to the contest will be previously evaluated by the Organizing Committee according to the thematic relevance of the Congress.

6.2 All **InterCorr 2025** participants may vote for three photos of their choice. The voting will close at 10 a.m. on July 11th and be conducted electronically at 10:30 a.m. on the same day.

6.3 The Contest and prize winners will be announced during the Congress Closing Session.

7 - AWARD

7.1. The authors of the photographs classified in first, second, and third places will be awarded one prize per classification.

7.2. If the awarded photograph has more than one author, only one prize will be given, and its apportionment will be between the authors. ABRACO is not responsible for the prize's destination.

7.3. In case of a draw, a raffle will be done to establish the rankings.

8 - EXHIBITION

All material submitted will be exhibited during the InterCorr 2025.

9 - GENERAL CONDITIONS

9.1. All Contest material, regardless of the prize, will be included in ABRACO's collection, which may be disclosed, at its discretion, without prior notice to the author(s).

9.2. Material not complying with this Regulation will be automatically disqualified for awarding; however, it may be part of the exhibition or ABRACO's technical collection.

9.3. The Organizing Committee of InterCorr 2025 will resolve all cases not covered herein.

9.4. Any form of disclosure by the author of his photograph, as well as any voting requests, is prohibited.

9.4.1 Noncompliance with this regulation will result in the disqualification of the photograph.

10 - SUBSCRIPTION

Confirming the subscription to the 22nd Photography Contest will imply full acceptance of this Regulation, and ABRACO has the right to disclose the submitted material.
